Minutes of the January 19, 2017 Membership Meeting

1. Call to Order and Introductions

- ➤ President Brad Ebaugh opened the regular membership meeting at The City of Dover, 10 Electric Ave., Dover DE 19904.
- ➤ Mission Statement: Our mission is to assist excavators, facility owners, and the public in the prevention of underground damages, service outages, personal injury, and their associated repercussions, through education and the promotion of the One Call System.
- > 28 members were present.
- ➤ Those present gave the customary introductions.
- > Tony Gersitz made a motion to approve minutes as amended, Mike Burns seconded, unanimously approved by the members.

2. Presentation- Miss Utility of Delmarva 2016 Annual Report to Members- Brad Ebaugh

Mr. Ebaugh reported on the condition of the USCPD. The organization promotes safe excavation through education and outreach. The Board has 12 members, with monthly General Membership Meetings which are open to the public. The USPCD is also a member of the Common Ground Alliance (CGA), a national organization which promotes Damage Prevention. provides a national forum for Damage Prevention, as well as training for USPCD Board USPCD sponsors Locator Awards, which recognize excellent performance by facilities locators. USPCD also supports the Greater Chesapeake Damage Prevention Training Conference (GCDPTC), a comprehensive training course which covers many topics important for Damage Prevention. For calendar year 2016, the USCPCD contractor (One Call Concepts) generated 1,278,670 outgoing locate tickets for the members. For calendar year 2016 ticket income was \$129,710.65, and expenses were \$108,657.30, for a net income of \$21,053.35. USPCD checking account was \$121,466.00 and the money market account was \$102,069.25 as of 12/31/2016. USPCD promotes Education & Public Awareness by publishing The Scoop, maintaining a Facebook page, and through Damage Reporting. The Board is also actively promoting a law change to enhance enforcement of Delaware excavation laws. promotes Safe Digging Month in April, holds contractor breakfast education sessions and the Dig Smart Awards.
