CALL TO ORDER, WELCOME AND INTRODUCTIONS

- President Lyon called the meeting to order at 9:03am.
- Reviewed the Miss Utility of Delmarva Mission Statement.
- Meeting Attendance, 34 participants (13 virtual attendees, 8 new attendees)
- Introductions were made by all attendees.
- A motion to approve the meeting minutes dated December 15 2022 was made by R. Lewis B, seconded by B. Ebaugh, motion carried.

ANNUAL MEETING OPENING STATEMENT

ITICnxt

Professional contractors and members have an improved method to process tickets as of December 1, 2022,. OCC reported 50% of the processed tickets have been created using ITICnxt.

This improved ticket processing module offers;

- one session mapping of any and all work sites located in the Delmarva territory
- ticket auto populated text fields based on the mapped work site
- multiple mapping tools selection; street, route, radius, property and other
- ticket processing business rules and state law is imbedded into the software and is the basis for ticket
- splitting
- one login for all the users web tools access
- redesigned ticket screen for easier ticket management

EXCAVATOR/MEMBER/LOCATING CONCERNS

A question was raised regarding some locators stating they do not have access to the ticket's map that has caused locate delays, additional site meetings and the use of additional resources. It was explained for the good of the order, that the call center transmits the excavation map with each ticket. However, each receiving station may use filtering software to to not display the map. It was also stated that anyone can view and print a ticket from Search and Status where the map is fully displayed and is printable.

- R. Lewis (Kleinfelder) stated in some cases the ticket field address is different from the Extent of Work when the address is typed in by the user. OCC reported they use a proprietary software 'IVerify' to isolate ticket user issues prior to the ticket being transmitted to avoid confusions. Direct calls are made to the user to resolve the issue and provide ticket processing education.
- E. Cimo (DelDot) reported they are doing what they can to address unlocatable buried utilities/facilities understanding the risk of possible damage. They do not encourage fake marks or no marks under these conditions.
- W. Stack (W. Locco) reported there is a future 2 to 4 year project from Queenstown, MD to the Bay Bridge.

Chat (James/City of Milford) inquiry; Can we have tickets marked as dispute show up as a ticket without response? We end up missing them often because they filter out under the default without responses filter. The only way to see them is to show all tickets and dig through for ones under dispute. OCC will contact James directly.

J. Sappe (Chesapeake) suggested a ticket processing enhancement to include the excavator's liability insurance information on the processed ticket. The board will discuss this at their executive meeting.
