# GENERAL MEMBERSHIP MEETING MINUTES HYBRID MEETING (Dover, DE)

May 19, 2022 Prepared by Dora Parks (Secretary)

**President's statement**, J. Lyon informed the membership that Tony Gersitz is having health issues resulting in being hospitalized recently. S. Keyser's father-in-law passed away.

J. Lyon stated the mission of Miss Utility of Delmarva and provided an overview of the meeting agenda.

# CALL TO ORDER AND INTRODUCTIONS

- J. Lyon (President) called the meeting to order at 9:04am.
- Attendance, 27 attendees signed into the virtual meeting.
- Introductions were made by all attendees.
- A motion to approve the meeting minutes dated April 21, 2022 was made by E. Cimo, seconded by R. Lewis, motion carried.

## **PRESENTATIONS**

ITIC PROFILES; S. Sullivan (OCC) presented on ITIC 'Profiles' creation and benefits. ITIC (Internet Ticketing) provides a user a short cut for ticket processing/creation titled, 'Profiles'. This feature (when created in advance) will auto fill many of the text ticket fields with one click on the association 'Profile' label or name. Once populated, any of the profile ticket fields can be changed for that particular ticket. Please note, the EXTENT OF WORK field is not a Profile field; this ticket field is populated based on the mapping tools selected and the ticket mapping created by the user.

The user can name each profile created for quick access when processing a ticket and fill-in as many offered profile fields as the user desires. This tool is useful when multiple tickets are processed with many of the ticket fields containing the same information. Susan also stated that this would be the last ITIC presentation unless requested by the Delmarva board.

MD TITLE 12 STATE LAW CHANGES; J. Barron (MD Authority, ED) presented the following information regarding the newest law change affecting the ticket's work to begin start date. *Please note, lower case sections relate to previous law and upper case sections relate to new HB 994 and SB 789 passed law.* 

MD - HB 994 & SB 789 Select Start Work Date Legislation Changes to §12–124 & §12–126 The following changes were passed during the 2022 Legislation Session, signed by the Governor on Monday, May 16, 2022, and will become law on June 1, 2022.

# §12-124. - Notice to One-Call System

- (a) "Before performing an excavation or demolition in the State: a person:
- (1) shall initiate a ticket request by notifying the one-call system serving the geographic area where the excavation or demolition is to be performed:
  - (2) SHALL SELECT A START WORK DATE THAT COMMENCES:
    - (i) NOT SOONER THAN 3 BUSINESS DAYS AFTER THE TICKET IS INITIATED.

      And
    - (ii) NOT LATER THAN 12 BUSINESS DAYS AFTER THE TICKET IS INITIATED:"
- (c) (i) "THE TICKET SHALL INCLUDE A RESPONSE DATE AND TIME FOR THE OWNER-MEMBERS OR THEIR CONTRACT LOCATORS THAT CORRESPONDS WITH THE START WORK DATE SELECTED BY THE PERSON WHO INITIATED THE TICKET.
- (II) A ticket is valid for 12 business days after the **SELECTED START WORK DATE** on **A** ticket **THAT** is transmitted by the one-call system to the owner-member **OR THEIR CONTRACT LOCATOR**."

#### §12–126. – Marking Requirements

- (c) "Except as provided in subsection (d) {Code 5} of this section, within 2 business days after the day on which a ticket is transferred to an owner-member **OR BEFORE THE SELECTED START WORK DATE.** the owner-member or is contractor shall:"
  - (1) "mark the location of the owner-member's underground facility..." or
  - (2) "report...that the owner-member has no underground facilities in the vicinity...".

#### §12–124. – Notice to One-Call System

- (b) "Notice provided to a one-call system under subsection (a) of this section shall indicate:
- (3) the type **AND EXTENT** of work to be performed in connection with the proposed excavation or demolition..."

# §12-101. - Definitions

- (n) "Extent of work" means a clear and concise description of work to be done at a property, including the property address or specific distance and direction from a specified point, not to exceed 1,320 feet, that completely depicts the scope of work and that the excavator can complete within the designated life of the ticket."
- J. Barron noted the MD Authority can only enforce Part 4, sections 120-130. With the addition of the *Extent of Work* definition and that this term was codified in 12-124, *Extent of Work* violations are now enforceable by the MD Authority.
- J. Barron addressed many questions regarding this latest addition to MD law and stated copies of the bill will be posted on the MD Authority website (<a href="www.mddpa.org">www.mddpa.org</a>) It was noted that excavators have a responsibility under MD law for marked utilities/facilities. Locate delays (Ticket Check 24 & 48 hours) still apply.

J. Arroyo (OCC, GM) stated the ability to select the excavator's work start date will be implemented for ticket processing about June 1st with a confirmation notice being delivered to MD call center stakeholders.

The Delmarva board will monitor this newest MD law requirement collecting stakeholder pros and cons to determine changes (if any) are needed to the current Delaware law, Title 26.

# EXCAVATOR/MEMBER/LOCATING CONCERNS

- E. Cimo mentioned changes to Buy America. Utility companies need to be aware that it is more than just steel & iron products. Effects any work where Federal funds are involved.
- T. Matich asked about ticket life responsibilities regarding mark maintenance.
- R. Lewis reported SMI services is a company installing silt fences and not processing tickets for member notification of their work. They have hit two different gas lines within the past few weeks. There has been educational outreach to this company, R. Lewis stated more is needed. SMI is performing work in Kent and Sussex County and seems to perform work for home builders. J. Barron reported that MD has received NPV's for this same company resulting in fines and training of MD law.
- A Century Engineering employee was struck by vehicle on Rt. 141 while working. R. Lewis reminded
  folks to be cautious, do not assume drivers are aware of excavators and locators working in the
  roadway areas, be safe.
