CALL TO ORDER, WELCOME AND INTRODUCTIONS

- President Lyon called the meeting to order at 9:01 AM.
- The Miss Utility of Delmarva's Mission Statement was reviewed by the President.
- The meeting agenda was presented.
- A quick point was made about the One Call Concepts Training Video for Delaware and Maryland. The classes are free and self-paced. They are educational and could be used as a disciplinary measure when a damage occurs.
- Introductions were made by all attendees. Virtual attendees were asked to enter name, company name, & contact information in the Teams chat.
- Meeting attendance included 29 participants in person and virtually.
- Tucker Bullock gave a safety moment about the upcoming winter weather. Please be mindful of slippery roads and surfaces as well as windier weather that could increase driving hazards. Your teams and families should discuss how to prepare for the winter weather and how to safely respond in a time of need. Also, be sure to have the appropriate clothing (warm weather layers, waterproof boots, head coverings), tools, and plans to work and travel safely. Lastly, do you have an evacuation plan for severe weather events?
- A motion to approve the meeting minutes dated October 19th, 2023 was made by B. Ebaugh and seconded by R. Lewis, motion carried.

ITICnxt – DIGITAL TICKET PROCESSING (PROFESSIONAL EXCAVATORS)

S. Sullivan gave presentation/overview. Miss Utility provides monthly ITICnxt virtual trainings. S. Sullivan provided dates for upcoming virtual trainings opportunities (12/7 at 2:00 PM – 2024 Dates will be announced in the near future). Excavators are encouraged to use online system. Visit <u>www.missutilitydelmarva.com</u> to pre-register for these training classes and review the many resources offered. There is a Google registration. Register a minimum of two business days ahead for these free training. Interactive online training is available

through the website along with several YouTube videos on how to use the system. The demo/sandbox site is still available. Online resources are available 24/7. EXCAVATOR/MEMBER/LOCATING CONCERNS

Some excavating contractors are having the utility owner call in their tickets for them. There was a scenario where two excavating contractors called two tickets called in. One ticket got marked sooner than another, and both contractors started working on the located ticket. There is a concern about this not being explicitly banned in the Delaware State Law. There was no damage associated with this event, but it was still concerning. B. Ebaugh noted that the Board can provide education or write letters to those contractors to hopefully achieve a behavior change.
